


Social security in the EU: what are your rights?

study, retirement, to look for a job – or just a holiday. EU rules cover your healthcare, pension, unemployment, family and other social security benefits, giving you peace of mind wherever you go. What's more, new rules have been developed to ensure you are provided with better information and services.
